# RUC FOR FOREIGNERS AND COMPANIES: REQUIREMENTS

### When should I get the RUC?

At the start of a legal business, to do commercial transactions in a legal manner.



What requirements are needed to register in the RUC?



# 2.1 Natural person:

### Foreign residents and/or Ecuadorians:

• Presentation of the original and submit a copy of the identification card or citizenship card.

### Foreign non-residents:

- Presentation of the original and submit a copy of the passport and current type of visa; or original refugee credential.
- a. Requirements for the RUC cancellation of foreign non-residents
  - Cessation of activities request / RUC cancellation (SRI offices or in the website www.sri.gob.ec.)
  - Presentation of the taxpayer original passport and current visa, or the original document of refugee credential.

### **NOTE: Previously, current sales receipts or authorization to print** own invoices should be discharged.

b. For the verification of the place where the economic activity is performed, the taxpayer should exhibit and submit:

- Utility bills (water, electricity or telephone).

- Bank, credit card or cell phone statement.

Original and copy of any of the following documents:

- Paid television services or internet services bills. - Any document issued by a Public Institution that shows

- taxpayer's accurate address. - Lease contract. - Deed of sale of the property; or original and copy of the
- Property Registry Certificate.
- Dealership agreement or Contract of Ioan.Certification issued by the Parish Council nearest to the
- home address.

## 2.2 Companies:

Requirements to obtain the RUC depending on the type of incorporation of the private company.

**Companies under control of the Superintendence of Companies** 

- RUC-01-A form and RUC-01-B signed by the legal representative.
- Original and copy, or certified copy, of the public deed of incorporation or domiciliation registered in the Mercantile Registry.
- Original and copy, or certified copy of the legal representative's appointment registered in the Mercantile Registry.
- Original and copy of the general data sheet issued by the Superintendence of Companies. **Companies under control of the Superintendence of**

### Banks: - RUC-01-A form and RUC-01-B signed by the legal

- representative. - Original and copy, or certified copy, of the public deed
- of incorporation or domiciliation registered in the Mercantile Registry. - Original and copy, or certified copy of the legal
- representative's appointment registered in the Mercantile Registry. **Civil and commercial companies**



- RUC-01-A form and RUC-01-B signed by the legal representative.
- Original and copy, or certified copy, of the public deed of incorporation registered in the Mercantile Registry.
   Original and copy, or certified copy of the legal representative's appointment registered in the Mercantile Registry.

De facto associations, independent or autonomous assets with or without legal status, participation account contract, a consortium of companies (joint ventures), holding company.

- RUC-01-A form and RUC-01-B signed by the legal representative. - Original and copy, or certified copy, of the public deed granted before a public notary or judge. Original and copy, or certified copy of the legal representative's appointment, notarized and with signature recognition.
- Non-governmental, non-profit organizations.

# - RUC-01-A form and RUC-01-B signed by the legal representative.

- Copy of the ministerial agreement or resolution that approves the creation of the non-governmental, non-profit organizations.
  Original and copy of the legal representative's appointment endorsed by the body to which the non-governmental non-profit organization is registered: Ministries or National Electoral Council.

# • Ecuadorians:

2.2.1 Identification of the legal representative and general manager:

# Copy of the identification card and exhibition of the voting certificate of the last election process.

Foreign residents: Copy of the identification card, if the foreign non-resident does not have an identification card, a copy of the passport with identification sheets and current visa type 10 shall be presented.

# Copy of the passport with identification sheets and current visa type 12.

Foreign non-residents:

### For the taxpayer resident abroad, an authorization letter signed by the resident abroad, with signature recognition before the corresponding Ecuadorian Consul, and containing information requested in previous paragraph or a general power of attorney or with a special clause that allows to the third party to perform the processes in the SRI.



# The taxpayers who want to update the information of identification, localization, economic activity or information of any type contained in the RUC must comply with the following

- Exhibition of the original identification card or citizenship card or passport, of the natural persons or legal representative or retention agent or liquidator appointed, performing the process in person. - Exhibition of the original voting certification. - Exhibition of the original and submit one copy of the document that supports the change
